RE: SPECIAL SECURITY ADVISORY. EFFECTIVE IMMEDIATELY. FOR ALL SOUTH BASE OPERATIONS AND SPECIAL SECTORS.

A SHUTDOWN HAS HERE BY BEEN ORDERED FOR ALL SOUTH BASE OPERATIONS AND SPECIAL SECTOR PROGRAMS. SPECIAL CONDITION PROCEDURES FOR SEQUENCE "BLUE FIRE" ARE NOW IN EFFECT. ALL ENLISTED PERSONNEL AND CIVILIAN PERSONNEL ARE TO BE BRIEFED ON A "BLUE FIRE" SCENARIO, ON A "NEED TO KNOW" BASIS ONLY. ALL SPECIAL SERVICE DIVISIONS, SPECIAL SCIENCES DIVISIONS AND EXECUTIVE SECURITY TEAMS WILL BE UNDER LOCKDOWN CONDITIONS OR ON RESTRICTED ROAM L.R.R.P. PROCEDURES.

ON 31 JULY 1991 AT 2000 HRS. A CIVILIAN ORGANIZED EVENT IS TO BE HELD IN THE TOWN OF RACHEL, NEVADA. THE INDIVIDUALS WHO HAVE ORGANIZED THE EVENT ARE FAMILIAR TO SECURITY TEAM PERSONNEL THAT HAVE HAD PRIOR CONTACT WITH PRIMARIES AND / OR THEIR SUPPORTERS. PRIMARY SUBJECTS ARE IDENTIFIED AS FOLLOWS:

BOTH OF THE SUBJECTS OPERATE THEIR ORGANIZATIONS FROM A POST OFFICE BOX IN THE CITY OF GARDENA CALIFORNIA. (PLEASE SEE PRIOR SPECIAL ADVISORY NOTIFICATIONS.)

BOTH SUBJECTS AND THEIR SUPPORT PERSONNEL WILL BE IN ADVISORY PERIMETER WITHIN A 48 HR. TIME PERIOD OF THIS NOTICE. ALL AREA PERSONNEL ARE TO REMAIN ON ADVISORY ALERT UNTIL 5 AUGUST 0500 HRS. AND PROCEED WITH CAUTION IF APPROACHED BY ANYONE BELIEVED TO BE AFFILIATED WITH THESE GROUPS. THESE SUBJECTS MAY ALSO BE ACCOMPANIED BY INDIVIDUALS FROM THE NIPPON TELEVISION NETWORK OR THE TOKYO BROADCASTING SERVICE OF JAPAN, IN ADDITION TO VARIOUS PRINT MEDIA PERSONNEL FROM VARIOUS ASSIGNMENTS BOTH NATIONAL AND INTERNATIONAL. ALL BASE COMMANDERS AND SECURITY TEAM PERSONNEL ARE TO INSTRUCT SUBORDINATES CONCERNED TO REPORT ANY HARASSMENT EITHER TO THEMSELVES OR ANY OTHER BASE PERSONNEL THAT THEY MAY BECOME AWARE OF. FAILURE TO DO SO IN A TIMELY MANNER WILL RESULT IN IMMEDIATE DISCIPLINARY PROCEDURES WITH NO EXCEPTIONS.

THIS EVENT IS TO BE HELD AT "THE LITTLE ALE-INN" FORMERLY, KNOWN AS, "RACHELS BAR AND GRILL". MR. AND MRS. TRAVIS HAVE GRANTED PERMISSION TO THESE INDIVIDUALS FOR THE USE OF THE FACILITIES ON THE EVENING OF 31 JULY 1991.

ALL BASE SPECIAL OPERATIONS IN SECTORS CONCERNED ARE TO BE RESCHEDULED TO AN ASSIGNMENT DATE AFTER 0500 HRS. ON 5 AUGUST.

SPECIAL SECURITY SERVICES ARE HEREBY INSTRUCTED TO COMMENCE WITH PROPER PROCUREMENT AND ENFORCEMENT OF SPECIAL SECURITY ADVISORY SECTIONS AND PRACTICES DURING THIS TIME PERIOD. IT IS EXPECTED THAT MEMBERS OF THESE GROUPS AS WELL AS OTHER FRINGE ELEMENTS WILL REMAIN IN AND AROUND THE GENERAL AREAS OF CONCERN FOR AS MANY AS A FEW DAYS PRIOR TO, AND FOLLOWING, THIS SCHEDULED EVENT.

ALL PERSONNEL BOTH MILITARY AND CIVILIAN WHO ARE BELIEVED TO BE OR KNOWN TO BE COMMUNICATING OR CORRESPONDING IN ANY WAY OR BY ANY METHOD WILL BE CONSIDERED TO BE IN VIOLATION OF THIS SPECIAL SECURITY ADVISORY AND THEREBY CHARGED WITH WILLFUL DISREGARD OF A SPECIAL SECURITY ADVISORY AND BE SUBJECT TO IMMEDIATE ARREST AND PROSECUTION FOR VIOLATION OF THE NATIONAL SECURITY ACTS.

NOTE; THIS DOCUMENT CONTAINS INFORMATION AFFECTING THE NATIONAL SECURITY OF THE UNITED STATES WITHIN DESCRIPTION OF THE ESPIONAGE ACT 30 U.S.C., 31 AND 32 AS AMENDED.
